

Minutes of the meeting of

1. Welcome and Apologies

ES welcomed all to the meeting and passed on RS' apologies that he would not be in attendance until 2pm.

2. Minutes of the Last Meeting

The minutes of the last meeting were approved.

EF stated that the timeframe for completion of the Annual Report was by Christmas.

3. Chair – News and Current Issues

- TTU Responsibilities

ES commended the recent work between the QLTR and NMS to define their respective responsibilities for the Treasure Trove Unit.

SA stated that there are currently three draft papers (Functions, Conflicts of Interest, Exceptional Circumstances) circulating between the QLTR and NMS. These are on track to be finalised by the original deadline of Spring 2019.

- Mutual Interests

Successful meetings have been held this year between the QLTR, TTU, HES and NMS to discuss mutual interests and how to best collaborate when they arise.

- Scotland's Archaeology Strategy

ES recommended that PY receive an invite for the next SAS meeting. Update to be given at March 2019 meeting.

- Museums of Last Resort

EF brought forward a concern that the time frame in which Museums of Last Resort had to bid for an object was too short. She proposed a new timetable of case lists being prepared eight weeks before a panel meeting instead of the current six weeks. This would allow four weeks for museums to apply, followed by a further four weeks for museums of last resort to apply for outstanding material.

There was general agreement for this from the panel, although a date for the implementation of the new time frame is yet to be set.

- 2019 Meeting Dates

The dates for the first two SAFAP meetings of 2019 were agreed as Thursday 14th March and Wednesday 19th June. The final meeting is TBC.

4. Staffing

SA provided an update that the latest round of recruitment for the role of Treasure Trove Manager had been unsuccessful and that NMS would re-recruit next year. Current staff members EF and EP are remaining in post for the foreseeable future.

5. TTU Report

EF provided an update for the Treasure Trove Unit's activities in 2018. This included a list of the outreach events held by the Unit, including visits to Elgin Museum, Shetland and the Highland Archaeology Festival. EF reported that a large number of finds were brought back down from these events. The Unit has recorded 575 individual objects in 2018, 181 chance find cases and 23 excavation assemblages were allocated.

6. AOCB

ES reported the Church of Scotland's request for minutes from the supplementary meeting regarding the Galloway Hoard allocation. The draft minutes of the meeting and subsequent appeal are being finalised by the Chair.

- TT 46/18 Intaglio Pendant

EF provided the background to a complaint made by the finder of TT 46/18 regarding the level of final ex gratia award. SAFAP recognised that an initial confusion in communication and a subsequent change in staffing within the TTU led to the finder

incurring additional costs. The panel agreed that a letter should be written to the finder and the individual reimbursed.

- PY brought up the possibility of the Treasure Trove Unit contributing in Current Archaeology. There was brief discussion around this with TTU staff concluding that this was something that can be considered.

- **Discussion concerning TT 128/18 Fragment of Stone**

SA (NMS) and MM, RW (HES) were absent for the first part of this discussion.

ES read out a statement from the QLTR stating that the Commissioners for the Safeguarding of the Regalia were content for this case to be allocated to an appropriate Scottish museum or institution through the Treasure Trove system.

Concerns were raised from the panel that the object in question did not qualify as *bona vacantia* and therefore could not be considered through the Treasure Trove system. Panel members also brought forward the question of ownership regarding the Stone of Destiny, and sought clarification on who owned the stone currently residing in Edinburgh Castle. The manner in which TT 128/18 was declared also gave cause for concern regarding the ex gratia payment. Many panel members felt that any payment should be dealt with by the owner of the Stone of Destiny rather than a recipient museum or institution.

Discussion was then deferred until RS arrived later in the meeting to answer questions and provide further information.

RS stressed that the Commissioners were content for SAFAP to provide a recommendation for allocation even though the object did not strictly fall under normal Treasure Trove remit. SAFAP felt that it could not provide such a recommendation at this point in time and instead offered the following advice:

1. SAFAP are very unwilling to consider any ex gratia payment in a Treasure Trove context.
2. The object does not qualify as Treasure Trove and should therefore stand completely outwith the normal system.
3. SAFAP understands that it is the most qualified body to provide allocation advice and is happy to do so at a future date upon request of the owner of the material, with the provision that it does so in the context of points 1 and 2.

The advice offered by SAFAP will be referred back to the QLTR.

After receiving further guidance from the QLTR, SAFAP were able to recommend allocation for TT 128/18.
